Course Content

Specific Learning Outcomes: (1) demonstrate understanding of the process of model development and analysis of biological systems; (2) demonstrate ability to formulate mathematical abstractions of biological systems and selection, implementation and interpretation of appropriate mathematical models; (3) demonstrate understanding of model verification and interpretation of results; (4) exhibit critical thinking and scientific judgement; (5) learn to search and read independently mathematical literature and synthesizing it; (6) accurately and effectively communicate ideas, arguments and analyses to range of audiences in written form.

Lecture Content: The lecture content covers the application of mathematics to model and analyze biological systems. Specific models to illustrate the different mathematical approaches employed when considering different levels of biological function will be discussed. The material consists of case studies of mathematical modeling of biological system and it may include such methodologies as cellular automata, agent based models, neural networks, networks, PDEs. Not all course topics will be covered at the same level of depth. All relevant resource course material will be posted on CourseLink at the time when the corresponding topic is covered.

Course Assignments: There will be 2 Take-Home Assignments, and a Final Take-Home Assignment.

Course Evaluation:

Take-Home Assignment I – 30%, due Thursday, February 11, 2021

Take-Home Assignment II – 30%, due Thursday, March 18, 2021

Final Take-Home Assignment - 40%, due Monday, April 12, 2021

Each Take-Home Assignment will be given at least 10 days in advance. The Final Take-Home Assignment will be given not later than by Friday, March 19, 2021. The Written Report of the Final Take-Home Assignment will be due on the last day of classes, i.e. on Monday April 12, 2021.

Submission format of your take-home assignments: Take-Home Assignment I, II and the Final Take-Home Assignment must be submitted as pdf files. All assignments will be checked on Turnitin for potential plagiarism.

Privacy Guide Recording of Lecture Material:
