

Course Outline Applied Time Series Analysis STAT*4360 Fall 2023

1) General information

Calendar Description: (0.5 credits)

This course will investigate the nature of stationary stochastic processes from the spectral and time domain points of view. Aspects of parameter estimation and prediction in a computationally intensive environment will be the presentation style. The methods developed in this course will have applicability in many sciences such as engineering, environmental sciences, geography, soil sciences, and life sciences.

2) Learning Outcomes

This course serves as an introduction to the analysis of time series. In this course, students will learn how to analyze time series data using R, as well as gain a theoretical understanding of time series methods. At the end of this course, students should be able to:

- Understand why time series data are unique, and why the analysis of such data requires specialized methods.
- Apply appropriate statistical models to time series data and interpret the results.
- Understand the theory behind basic time series models and methods.
- Critically analyze complex time series in the context of a scientific question.
- Create reproducible data analysis reports using R Markdown.

3) <u>Topics covered:</u>

- Time series decomposition
- Stationarity, autocorrelation and its estimation
- Linear filters
- ARMA/ARIMA models, model selection and parameter estimation
- Time series regression
- Analyzing time series in the frequency domain
- Time permitting: (G)ARCH models, time series of counts, state-space models

Email etiquette:

Grading Policies:

Assignments: The assignments are due at 11:59pm on the due date and are to be completed independently. I expect your assignments to be reproducible, meaning that I should be able to compile your code and reproduce your pdf with minimal effort. I will demonstrate how to do this in the first week of class. If you can't hand in an assignment on time because of a valid reason, you must contact me as soon as possible to discuss a potential accommodation.

Discussing problems with your classmates or using search engines/chatbots is encouraged in this class, as this is how you solve problems in the real world. **However, any work that you submit must be entirely your own.** Academic dishonesty, such as plagiarism (including copying all or part of an assignment) and impersonation is grounds for loss of course credit and dismissal.

Projects: Projects may be completed in groups of up to 2 and will consist of a proposal and final report. Further details will be posted on Courselink early in the semester.

Late assignments and project components will be penalized at 5% per day up to 3 days. An assignment/project component that is more than 3 days overdue will receive a grade of 0, unless an accommodation is granted.

Quizzes: There will be 5 quizzes throughout the semester. Your lowest quiz mark will be dropped. If you miss a quiz for ANY reason, then that mark will be dropped. If additional quizzes are missed for a medical reason, you may be asked for further documentation to receive accommodation. If missed for a compassionate reason, you may be asked to discuss this with your program counsellor before receiving accommodation. If an accommodation is granted, the weight of the missed quizzes will be shifted to the completed quizzes.

When you cannot meet a course requirement:
